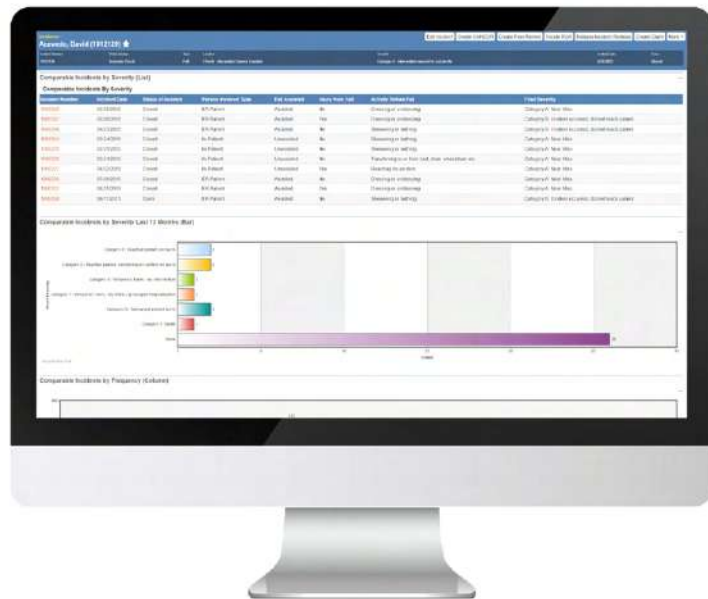


## PSO Integration
